VILLAGE OF DEBDEN

BYLAW 2/92

YLAW TO CLASSIFY, REGULATE AND LICENSE ANY BUSINESS, TRADE OR CALLING NOT ASSESSABLE FOR THE PURPOSE OF BUSINESS TAXATION IN RESPECT TO THEIR BUSINESS, TRADE OR CALLING.

THE COUNCIL FOR THE VILLAGE OF DEBDEN, IN THE PROVINCE OF SASKATCHEWAN, ENACTS AS FOLLOWS:

- 1. IN THIS BYLAW THE EXPRESSION"TRANSIT TRADER" SHALL HAVE THE MEANING ASCRIBED TO IT BY THE URBAN MUNICIPALITY ACT, 1984.
- 2. NO PERSON SHALL CARRY ON ANY BUSINESS, TRADE OR CALLING SET OUT IN SECTION 9 OF THIS BYLAW WITHIN THE MUNICIPALITY UNLESS HE HAS IN HIS POSSESSION A VALID AND SUBSISTING LICENSE FOR THE PURPOSE ISSUED IN ACCORDANCE WITH THE PROVISIONS OF THIS BYLAW.
- 3. THE ADMINISTRATOR OF THE MUNICIPALITY IS HEREBY AUTHORIZED TO ISSUE A LICENSE TO ANY PERSON CARRYING ON A BUSINESS, TRADE OR CALLING IN THE MUNICIPALITY.
- 3(A) WHO IS NOT ASSESSABLE BY THE MUNICIPALITY FOR THE PURPOSES OF BUSINESS TAXATION IN RESPECT TO THAT BUSINESS. TRADE OR CALLING; AND
- 3(B) WHO MAKES APPLICATION FOR SUCH LICENCE STATING SPECIFICALLY THE NATURE OF HIS BUSINESS IN THE MUNICIPALITY: AND
- WHO TENDERS WITH HIS APPLICATION THE PROPER LICENCE FEE AS PROVIDED IN SECTION 9.
- 4. EVERY LICENCE ISSUED UNDER THE AUTHORITY OF THIS BYLAW UNLESS SUSPENDED OR REVOKED SHALL EXPIRE ON THE THIRTY-FIRST DAY OF DECEMBER OF THE YEAR OF ISSUE.
- 5. WHERE A LICENSE IS ISSUED AFTER THE 30 DAY OF JUNE IN ANY YEAR, THE FEE PAYABLE UNDER SECTION 9 SHALL BE REDUCED BY FIFTY PERCENT.
- 6. EVERY LICENSE SHALL SPECIFICALLY STATE THE KINDS OF SERVICES, GOODS, OR MERCHANDISE WHICH THE LICENSE IS AUTHORIZED TO OFFER FOR SALE OR TAKE ORDERS FOR AS THE CASE MAY BE AND WHETHER IN THE CASE OF GOODS OR MERCHANDISE, HE MAY OFFER THE SAME FOR SALE BY RETAIL OR PUBLIC AUCTION OR BOTH. SUCH LICENSE SHALL ALSO STATE THE RESTRICTION AS SET FORTH IN SECTION 7 HEREOF.
- 7. NO PERSON TO WHOM A LICENSE HAS BEEN GRANTED UNDER THIS BYLAW SHALL OFFER FOR SALE SERVICES, GOODS, OR MERCHANDISE OR SOLICIT ORDERS FOR FUTURE DELIVERY OF GOODS OR MERCHANDISE WITHIN THE VILLAGE:
- 7(A) OTHER THAT A KIND OR KINDS DESCRIBED IN THE LICENCE; OR
- 7(B) BY ANY METHOD EXCEPT AS STATED IN THE LICENSE; OR
- 7(C) AT ANY TIME OR DURING ANY PERIOD WHEN SHOPS WITHIN THE VILLAGE OFFERING FOR SALE OR TAKING ORDERS FOR SIMILAR SERVICES, GOODS OR MERCHANDISE ARE IRED BY VILLAGE BYLAW TO BE AND REMAIN CLOSED.
- 8. EVERY PERSON LICENSED UNDER THIS BYLAW SHALL, AT ALL REASONABLE TIMES, UPON REQUEST OF THE ADMINISTRATOR, THE BYLAW ENFORCEMENT OFFICER OR LICENSE INSPECTOR, OR ANY PEACE OFFICER, PRODUCE SUCH A LICENSE FOR INSPECTION PURPOSES.

9. SUBJECT TO SECTION 5, THE FEE PAYABLE FOR A LICENSE UNDER THIS BYLAW SHALL BE AS FOLLOWS:



) FOR A TRANSIENT TRADER \$ 50.00 PER YEAR.

9(B) FOR A CONTRACTOR WHO ENTERS INTO CONTRACTS FOR THE CONSTRUCTION.

8. SUBJECT TO SECTION 5, THE FEE PAYABLE FOR A LICENSE UNDER THIS BYLAW SHALL BE AS FOLLOWS:

9(A) FOR A TRANSIENT TRADER \$ 50.00 PER YEAR.

9(B) FOR A CONTRACTOR WHO ENTERS INTO CONTRACTS FOR THE CONSTRUCTION. ALTERATION, REPAIR, OR REMOVAL OF BUILDINGS OR STRUCTURES, THE INSTALLATION OF HEATING UNITS, PLUMBING OR OTHER FIXTURES. ELECTRIC WIRING, OR PERFORMANCE OF OTHER SIMILAR WORK IN THE MUNICIPALITY \$50.00 PER YEAR

10 ANY PERSON WHO CONTRAVENES THE PROVISIONS OF THIS BYLAW IS GUILTY OF AN OFFENCE, SHALL BE LIABLE TO THE PENALTY PROVIDED FOR BY THE GENERAL PENALTY BYLAW OF THE MUNICIPALITY.
