Reminder to Residents

Municipal property and vacant lots, including ditches, **are not to be used** for grass clippings, branches or leaves. These items can be disposed of at the Hwy 55 Waste site. Grass clippings and leaves may also be bagged separately in a clear bag and tagged to be picked up on Garbage days.

Vacant lots and ditches are also not to be used in the winter months for snow removal from driveways and personal properties. This causes additional work for our Foreman in the spring when it is time to ensure water is flowing during spring thaw.



Animal Owners

Please be reminded that your pets must be on your property or on a leash at all times! Also, please pick up after your pet. Your neighbors do not want to pick up your animal deposits!!

Also be reminded that vacant lots, or any Village property are not to be used as an animal bathroom.

The Animal Nuisance Bylaw may be read in full on the website or at the Village Office.

Municipal Elections

The next general election will be on **Monday, November 9, 2020.**

After the Notice of Call for Nominations has been posted, nominations can be filed at the Municipal Office at any time during Regular Office Hours or from 9:00 a.m - 4:00 p.m. on **Nomination Day** (October 7, 2020.)

Who Can Run?

Persons eligible for nomination must:

- ⇒ Be at least 18 years old on Election Day
- ⇒ Be a Canadian Citizen at the time that the nomination paper is submitted
- ⇒ Have resided in the Village of Debden for at least 3 consecutive months immediately preceding the date the nomination paper is submitted; and have resided in Saskatchewan for at least 6 consecutive months immediately preceding the date the nomination paper is submitted

Nomination Papers must be signed by at least 5 eligible voters of the municipality.

Development/Building Moving/Demolition

Zoning Bylaw 2-87 (and accompanying Amendments) require that “every person before commencing any development or use within the Village shall apply for and obtain from the Development Officer, a **Development Permit**.” This includes decks, fences, detached garages, new construction and/or renovations that may affect load bearing walls.

Moving and/or Demolition Permits are also required for **any** building being moved into or out of the Village, (including sheds, garages and sea cans) and for any demolition of buildings within the Village.

Permits are presented for approval at Regular Council meetings held the second week of every month. Please take this into consideration when submitting your application.

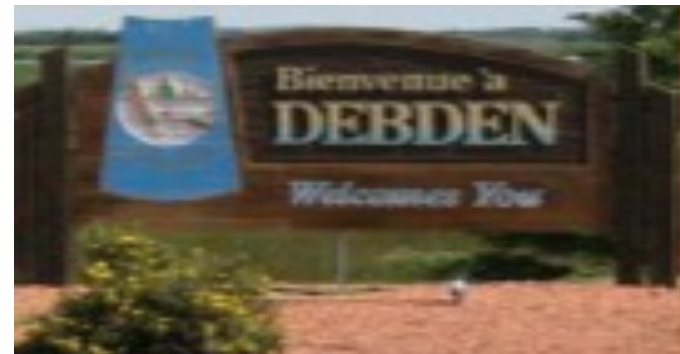
The Village has appointed **Chris Gates** as our **Municipal Building Official**. Forms, checklists and information are available at: **www.buildtechinspections.ca**
